5.1 Signage of War Graves - DECISION: Councillors voted 6 for, 1 against(CP), 1 abstain(RT) for signage for Commonwealth War Grave signage. Cllr Pratt will download the necessary details and pass them to the Clerk

5.2 Public Spaces Protection Order - DECISION: Councillors decided that it would be difficult to find someone to enforce dog fouling regs if we apply and receive this power and therefore, at this point, decided not to apply for it

5.3 Membership of VCSE - Community Action Suffolk - ESPC is now a member of CAS

DC/16/3062/LBC Old Hall Farm House, Church Lane - Restoration of pan tile garage and roof light reusing old tiles as possible and matching replacements. New single glazed roof light on rear elevation to match existing one - *No objections*

DC/16/3320/FUL The Gables - relocation of 19thC butchers hoist mechanism from existing chicken shed (former slaughter house) into purpose built shelter on west of chicken shed. On 1904 tithe map a small building was indicated in this location - this was original western yard to slaughter house - *No objections*

DC/16/3524/FUL Yew Tree Court (plot 1 MonarchWater) Erection of employment premises inc variation to conditions 17, 18 of outline permission DC/15/2705/OUT Oct 2015 Primary B1 use with ancilliary B8 storage with new external hard standing

Earl Soham Parish Council object to this application on the following grounds:

Outline permission was B1 (office) the change to B8 (storage/warehouse)would allow a very large building totally out of proportion to the initial application and not in scale/keeping with the existing buildings on the site. There is also provision for HGV turning so implies extra heavy lorry movement. Concerns were raised by the public that the hours of use would be extended from 7pm to 8pm disturbing those living nearby and these concerns were agreed by the council. Comment was also made re the colour of the proposed warehouse - grey would be more visible than the green used by the Walnes building further up the road and the council would wish to add a clause that the colour be more sympathetic
